Benefits are available to most people who meet the financial requirements, and the program serves a broad spectrum of low income people. In Fiscal Year 2011, SNAP provided about \$497.4 million dollars in food benefits to a monthly average of 345,955 people in West Virginia. The program served 83 percent of those eligible for benefits in West Virginia in 2010. SNAP also has an economic multiplier effect; every dollar in new SNAP benefits results in \$1.80 in total economic activity.
